### Corporate Profile

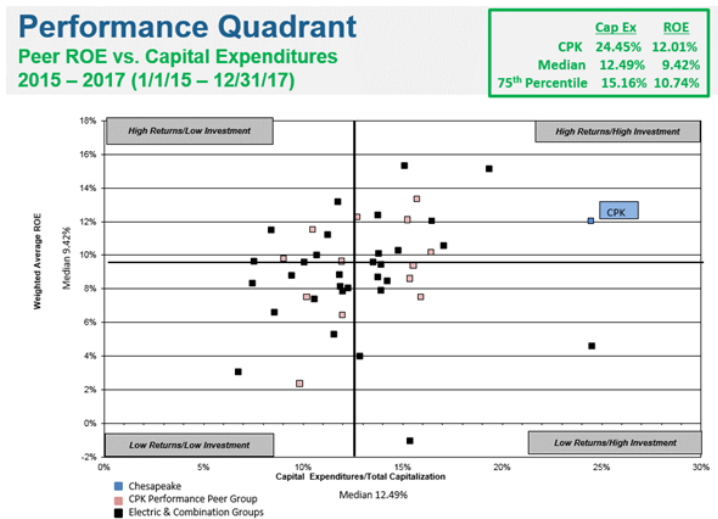

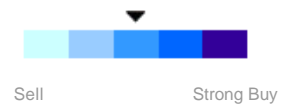
